However, English subjects face challenges at primary and secondary levels due to lack of focus, communication, and non-use in the home environment. The government lacks sufficient measures to improve English proficiency among secondary school students. Factors causing students to lack skills are not statistically available. A research study was conducted on the performance of students in public schools in Nushki district, focusing on scientific lines.

Thousands of scholars and scientists are presenting their research results in English language in different countries. And innumerable books and standard journals and magazines are being published every year in which modern and fresh content is available in all subjects. Importance of English education after the establishment of Pakistan

The first English school was opened in Karachi in 1853, and it marked a milestone in establishing English education in Sindh. English has been associated with freedom struggles, inspired independence, and has become the language of international trade and industry. However, after Pakistan's establishment, the importance of English decreased, and the need for a national language became more felt. Today, the importance of English is rising again, particularly among students pursuing higher education in foreign countries.

Problems of English Teaching in Pakistan

Teaching English is an important process. But many problems are encountered during its teaching in Pakistan, due to which the students are not able to show much better performance in English language.

It is generally believed that the quality of education in Pakistan is rapidly declining. One of the reasons for this is lack of financial resources and poor education policy. The education we want to impart. Students are not following it; they just memorize the words. While they do not know the rules and principles of grammar. The reason for this is that we do not count its marks at the graduation level, so students are satisfied with just writing. Even after 65 years, we have not been able to formulate a clear policy about the English language.

After finding out reasons why learners have a hard time in being proficient in English, solutions can be found to help learners to improve their language skills. Learners need to invest more time to practice English. It is because time investment has an influence on English achievement (Rintaningrum, 2018). The more students practice listening, reading, writing, or speaking in English the more familiar and confident they will be in English. Moreover, students need to spend more time to improve their grammar and vocabulary. The more the grammar and vocabulary improve, the higher the score students will get (Rintaningrum, 2018).

Absence of Clear Policy

The discrepancy between the actual needs and the halfhearted language policy is responsible for a lot of confusion in the field of English language teaching. English is a compulsory subject from class VI to the graduation level. Karachi University will not award a B.A, B.Sc. degree unless the student has obtained 33% marks in English, yet these marks are not including in their division. If the laws of "educational psychology" are applied to this situation it would be termed as definite determent in motivating learners.

Also, the English curriculum is substandard which does not meet the needs of students. If they want to learn English, they have to go to a private coaching center.

Poor teaching method

Poor teaching methods are used to teach English in our country. Translation method is prevalent in Urdu medium schools which can never play an effective role in teaching any language. In this way, students learn to read and write, but they never develop the ability to speak, nor are they aware of the inflections of words.

In the education system of any country, the teacher plays an important role. If the teachers are well educated and trained, then the quality of education increases. If an English teacher has poor knowledge about the subject, how can he Can teach students properly. Obviously, male and female students will also be weak in English. As today in our country the performance of male and female students in English is quite weak.

Many educational policies are made in our country which are not implemented in the true sense. We should not establish a standard system today about improving the quality of education after 65 years.

- English education in government schools is lacking due to government disinterest
 and unqualified teachers. Students struggle with blackboard questions and
 memorizing subjects, while female students and teachers help them pass exams.
 Poor education leads to students failing exams, but some qualified teachers report
 improvement in English when tutored.
- According to the opinion of the teachers, the illiteracy of parents is an important
 factor in the poor performance of English education. There is no concept of English
 communication in the home environment of the students that they are trained under
 the mother tongue. For which learning a new language becomes very difficult.
 Especially in the likes where the population is backward and the parents are
 uneducated. Parental influence on education and training is very powerful as
 students spend more time at home.
- The curriculum reflects the opinions of both male and female teachers, promoting
 modern science and incorporating gender-neutral content. However, it lacks girlfocused elements, making it difficult for girls in eighth grade. Effective English
 teaching from a young age can lead to improved language skills, but can also be
 susceptible to change.
- The president of teachers believes the support budget's teaching duties can be proven, but the government cannot provide assistance. Government schools have a large student population, making it difficult to focus on them. Poor English language teaching is caused by multiple factors, including controlled education and private online schools for both male and female students.

Discussion

For independent interviews with a group of male and female students, the following conclusions were drawn.

According to the opinion of male and female students, they do not say much enthusiasm in teaching the English subject of logic. It is read through the method of translation. Grammar is explained, but students' arguments are not covered by grammar. Due to the lack of communication and understanding of English in the class, the students try to memorize the lessons.

Aid funds are not used during education, which makes learning English difficult for students. Very little support from the parents to the students, most of the children are supported by Tuesh! Most of his nation fails in English essay. The textbooks are suitable for female students, but the textbooks of the 8th to 10th standard do not have any connection with the previous topics, due to which they feel difficulty. In government schools where English teaching is somewhat better, female and male students are able to write short sentences. But you have a large number of schools where students do not know how to speak, read and write even a single sentence of English. In the opinion of the students, many teachers are not able to pronounce the correct words themselves, nor write the class on time.

Students receive excessive homework, with few opportunities for check-ins. Teachers primarily focus on written work, neglecting oral practice. Primary English teaching is recommended for a strong foundation and avoiding difficulties in secondary levels. Additional subjects should be taught to increase English attention.

Conclusion

In the research paper under review, the researcher has created hypotheses and stated the assumptions. Based on these assumptions and assumptions, the following conclusions have been drawn by analyzing the data obtained with the help of questionnaires and interviews.

- Majority of the teachers and parents of the district Nushki at the secondary level are not satisfied with the teaching of English subject.
- The majority of students fail in the progress of the English subject and their performance do not have better in this subject.
- The teachers themselves are not proficient in the English language and due to their unsatisfactory teaching, the students are also cannot perform well in English subject.
- Teachers are appointed on the basis of recommendation and nepotism instead of skill and merit in the relevant subject. Teachers perform educational duties that are in no way qualified to teach English.
- According to the personal opinion of the majority of teachers, they often use Nigerian language in the class to explain the same subject. But according to the opinion of the president of the teachers, the teachers are incompetent and during the course of teaching, the group to explain the subject itself.
- Due to the large number of students in the classes, teachers are also unable to teach English effectively remain unable.
- In view of the importance of English, the teachers prepare this subject before teaching the students. President teachers and according to the opinion of educators, teachers do not prepare before teaching.
- English teachers make students practice sentences in writing, but they are not given oral practice.

- Students are checked on their work and mistakes are also discussed, but according to the opinion of the president teacher. Most people don't check homework on time or point out mistakes.
- Write the basic grammar sentences to the female students but a large number of the female students are unable to because of this.
- Due to the illiteracy of the parents, most of the students and families are unable to learn English at home
- There is no English environment available to girls in schools.
- In families too little attention is given by parents due to which most number of children resort to tutoring.
- Apart from the method of translation, the method of reading is the most used in schools.
- The results show that the majority of female and male students are interested in English subject but do not want to understand it in English.

Recommendations

Keeping in view all the findings, few recommendations are formulated which if implemented with integrity will yield encouraging results.

- In all government secondary schools in the district Nushki, not enough attention is paid to the teaching of English and students despite being proficient in other subjects, they are weak in English. For better teaching of students of every school English language should be used as much as possible in the environment.
- It is the responsibility of the government to appoint trained teachers to make the teaching of students effective. Organize refresher courses for teachers, workshops and seminars to train talented teachers for students' better education.
- Since 2006 not only English teachers but also JVT. 500, 750, 1000 as JET, and SST teachers teaching allowance is being given but the remuneration of English teachers should be increased so that they give special attention to English teaching and perform teaching duties more diligently.
- The number of female students in the appropriate group should be five so that attention is given to each student.
- Students should try to speak as well as write the basics of English language. Create an atmosphere of conversation in the congregation and reduce the bias of people among students.
- In order to improve students, students should be interested in simple subjects.
- The curriculum includes lessons to develop the tendency to speak English.
- In order to create more interest and proficiency in English language among students, teachers should familiarize the students with words that sound similar to the mother tongue like bicycle, ball pen, bulb etc. That there are words that are used in every language and students are already familiar with such words, therefore, more English vocabulary should depend on these types of sounds.
- Special attention should be given to the monthly examination of English subject in
 educational institutions. And in this regard to the Department of Education clear
 instructions should be given to the heads and the supervisory teams of the education
 department should conduct regular inspection and examination of the students
 check the copies and also do practical evaluation of the students so that the correct
 situation can be assessed the hardworking teachers and students.
- English subject should be given attention from the first grade because it is a foreign language and in difficulty for students renders and takes longer. For this both boys

and the female students cannot pay proper attention to him. As a result, the abilities and interests of female and male students are neglected.

- There should be a period for the teaching of English language in schools in English.
- It is also the duty of parents to check their children's English copies from time to time. And have homework completed carefully that parents know to read to children themselves.
- In addition to the English subject in schools, for example, math and science subjects are also in English for level correction. By using more words in this way, the English of students is somewhat standard.
- It is important for teachers to prepare lessons before teaching so that students can be more comprehensive information can be provided.
- It is necessary for teachers to make children read newspapers published in English daily and explain to them.
- Teachers should take the students to the nearby entertainment places and make them have fun there and speak English teach trick phrases.
- To teach English language, teachers should conduct various scientific activities to students in the class so that children English be more interested in learning.
